The meetings will be scheduled by the student based on his/her schedule and the schedules of the committee members. Each meeting should last about 1.5 hours. Thesis committee service is a valued responsibility and an expected component of the faculty's service to the University of Cincinnati and to the School of Art.

It is a responsibility of all thesis committee members to evaluate/edit the student's thesis paper and to provide feedback about the paper to the student. Agreeing to chair the thesis committee requires additional responsibilities in working with the student to develop the thesis paper, presiding over the oral defense of the thesis, procuring signatures on the thesis authorization form from the student and the thesis committee members, and delivering those forms to the School of Art Program Manager.

It is the responsibility of the student to arrange all thesis committee meetings with their committee members and to arrange alternate members for situations in which the faculty members who have agreed to serve on their committee are not available during the semester the student plans to graduate. This pertains to faculty members on scheduled university leave.

By signing this Thesis committee form, the student and thesis committee member acknowledges and accepts these responsibilities.
